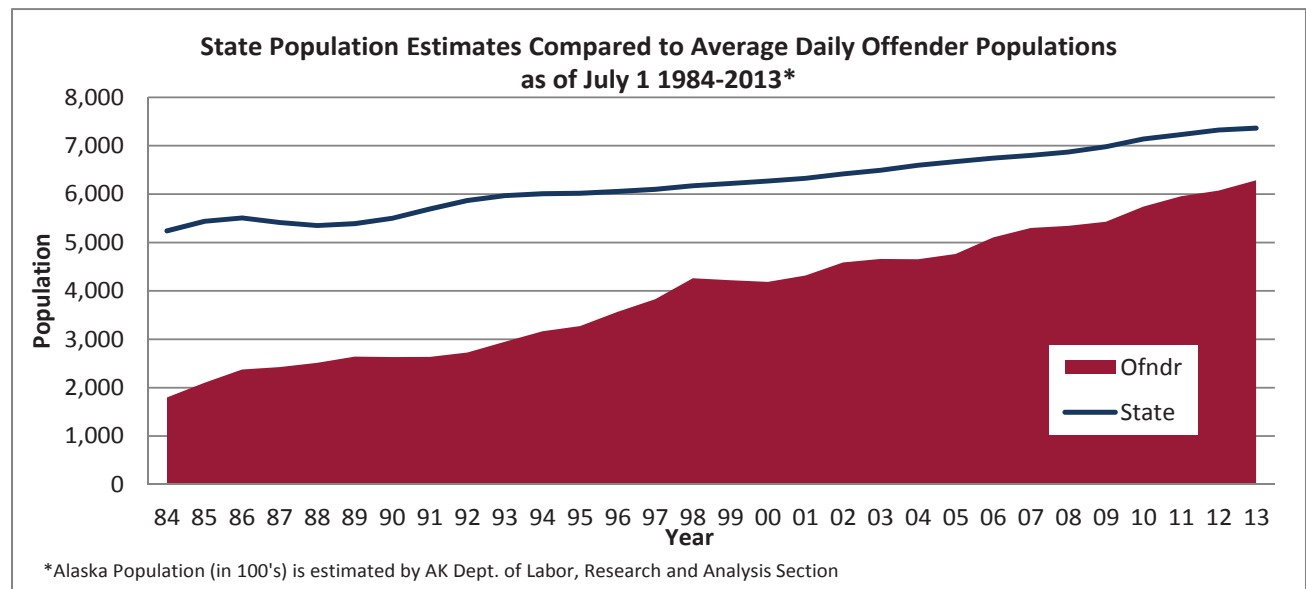

Admissions data includes all criminal admits (except transfers) for all offenders.

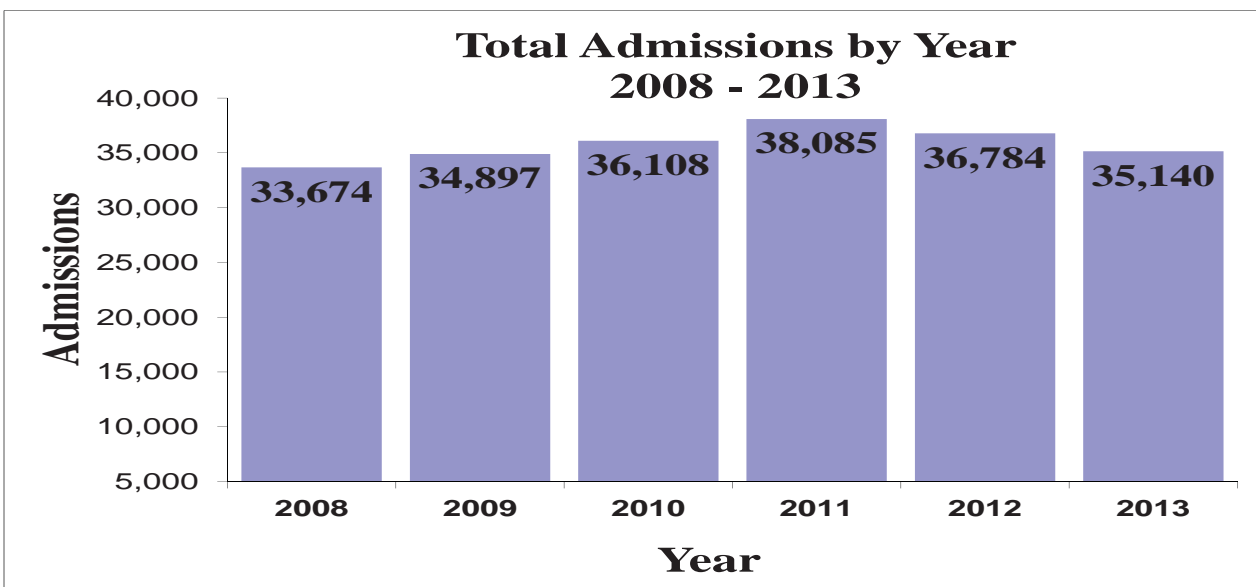
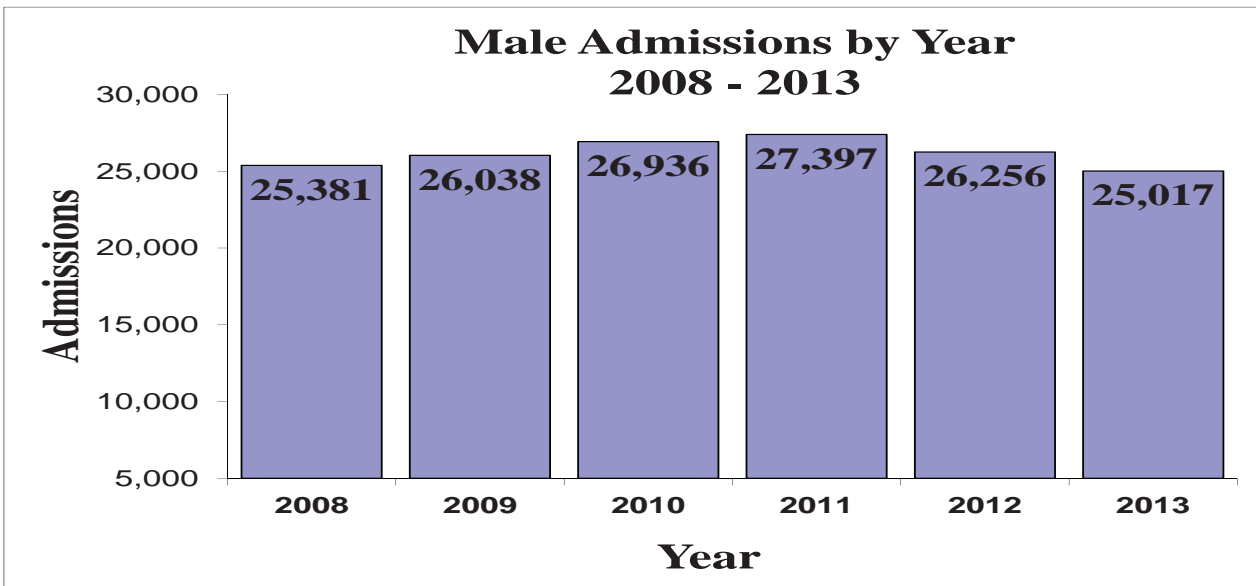
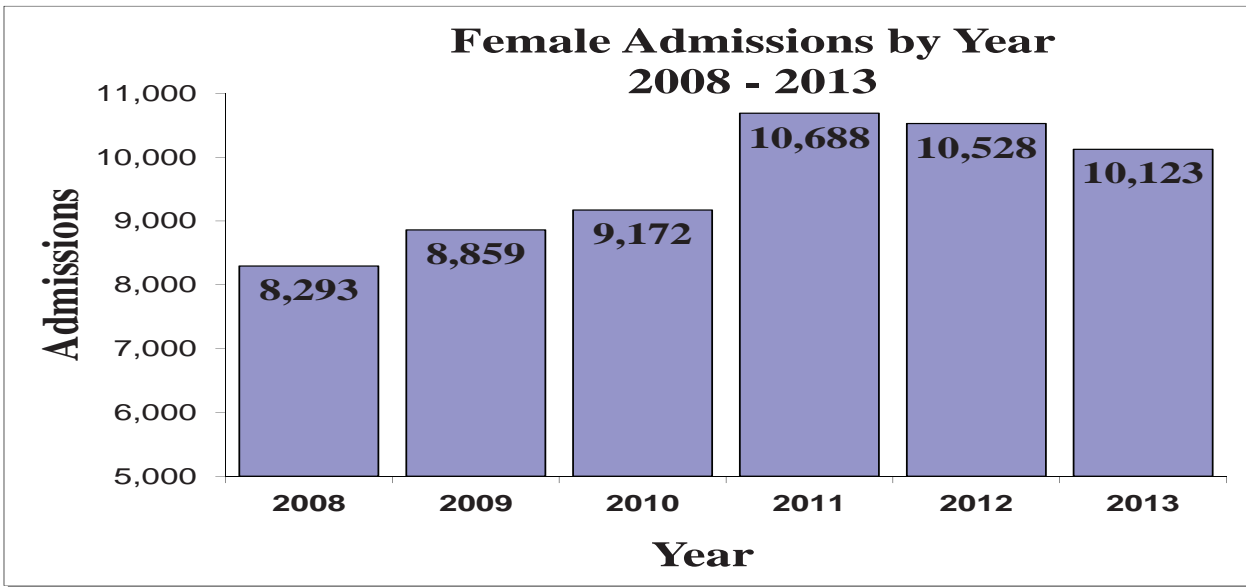

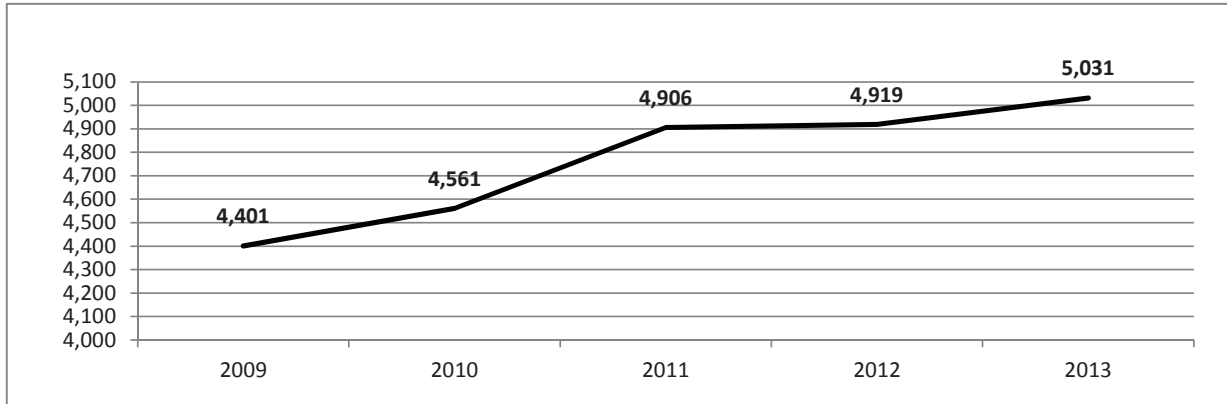

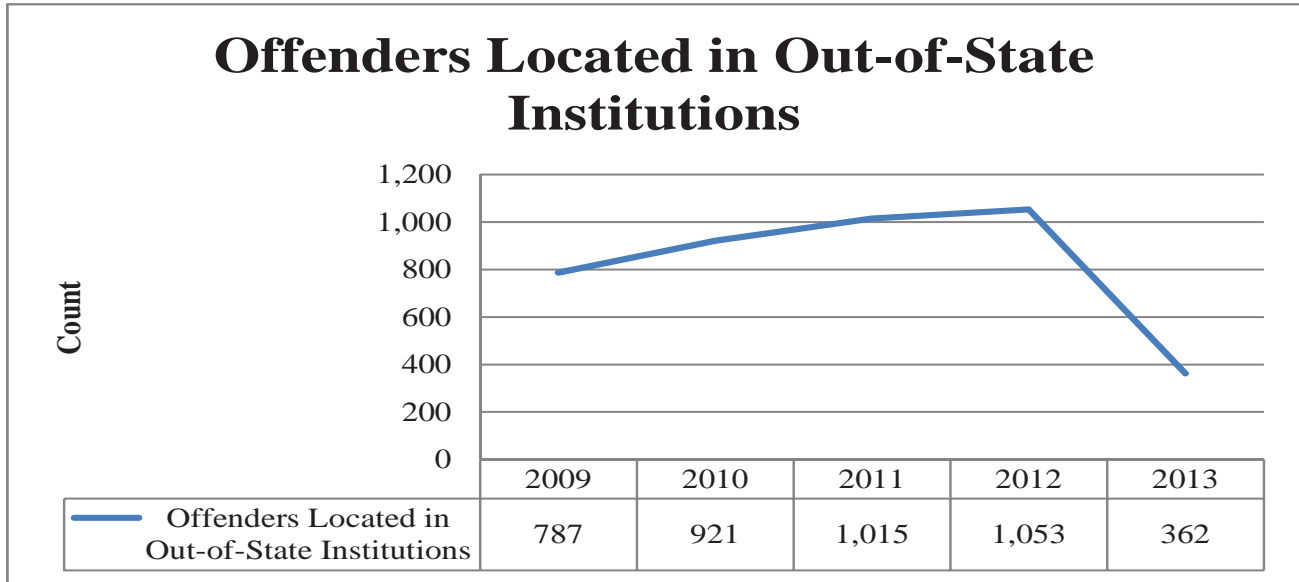

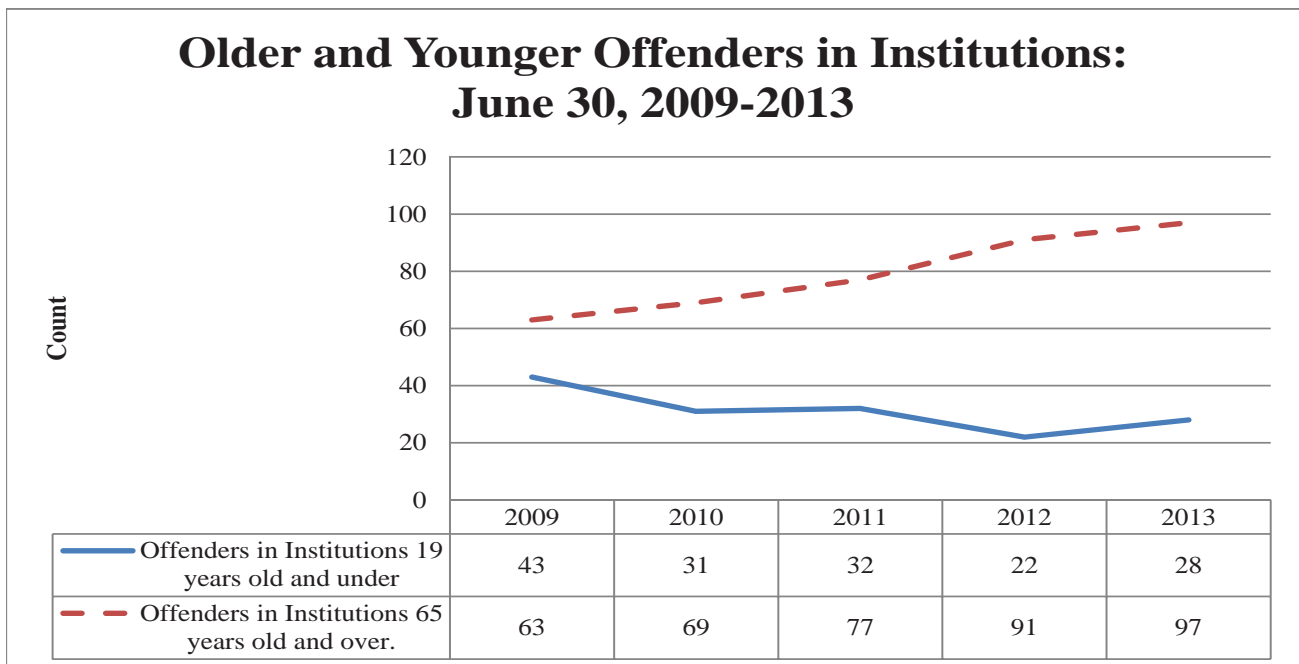

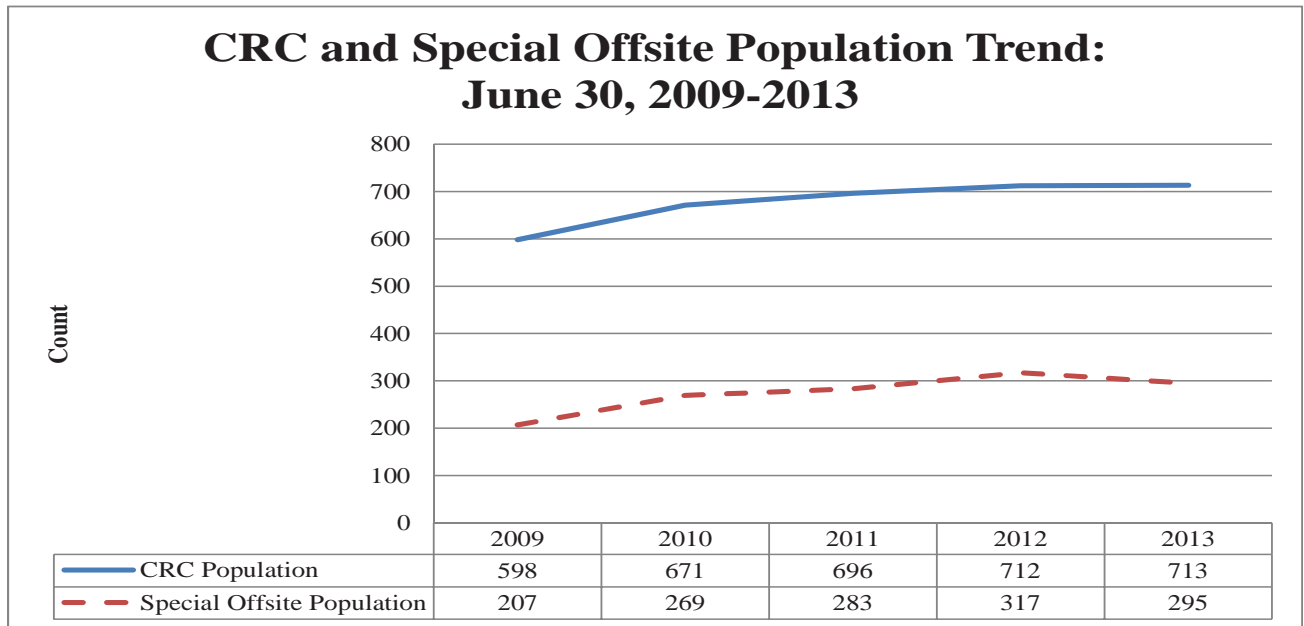
Since, by definition, a recidivation can take up to three years to return to incarceration, the most recent available year is 2010.
